- Mountain Overlay District Administrative Review Ordinance:** A public hearing on and consideration of: an ordinance of Blaine County, Idaho amending **Title 9, Chapter 21: Mountain Overlay District (MOD)**, adding a new section, 6, Administrative Boundary Review; providing for an application and fees; administrative analysis standards for review; administrative decision process with a notice of appeals to the Board of County Commissioners from administrative decisions; providing a severability clause and effective date. Following duly noticed public hearings on November 12 and December 10, the Planning and Zoning Commission unanimously recommended denial of the administrative boundary review procedure by Findings signed on January 14, 2010.
