- **Continuation of Deer Creek Watershed Restoration Project - Idaho Conservation League (ICL), Trout Unlimited (TU) and National Forest Foundation (NFF) applicants, with partner U.S. Forest Service (USFS):** Continuation of the February 23rd public hearing on and consideration of the Full Application for conceptual approval for funding for the project from the Land, Water & Wildlife Levy for \$496,300 total for (a) the restoration of 1,535 acres of upland vegetation and white bark pine (\$105,300) and (b) floodplain restoration and road relocation (\$391,000) to be matched with funds from the USFS, on USFS land northwest of Hailey in the Deer Creek drainage that were burned during, and otherwise damaged after, the 2013 Beaver Creek Fire. Other project components including recreational improvements and additional ecological restoration will be funded by the USFS, NFF, 5B Restoration Coalition, and Idaho Dept. of Parks and Recreation.
