

BLAINE COUNTY RESOLUTION NO. 2020-__

A RESOLUTION OF THE BLAINE COUNTY BOARD OF COMMISSIONERS ENACTED PURSUANT TO IDAHO CODE § 67-6509, ADOPTING REVISIONS TO THE BLAINE COUNTY COMPREHENSIVE PLAN SECTION 3: ECONOMIC DEVELOPMENT, WHICH WAS ADOPTED BY BLAINE COUNTY RESOLUTION NO. 94-29.

WHEREAS, the Blaine County Board of Commissioners adopted the Blaine County Comprehensive Plan by Resolution No. 94-29 on November 4, 1994;

WHEREAS, Idaho statutes Title 67 Chapter 6509 states, No plan shall be effective unless adopted by resolution by the governing board. A resolution enacting or amending a plan or part of a plan may be adopted, amended, or repealed by definitive reference to the specific plan document;

WHEREAS, the Board of County Commissioners initiated amendments to update the Comprehensive Plan on July 2, 2013;

WHEREAS, the Blaine County Planning and Zoning Commission considered the proposal to adopt Chapter 7 - Economic Development, at duly noticed hearings on November 21, 2019 and January 9, 2020, where they heard public testimony and recommended findings to amend;

WHEREAS, after receiving the Commission's recommendation, the Board of County Commissioners held duly noticed hearings on March 9, March 10, and June 16, 2020;

NOW, THEREFORE, BE IT RESOLVED THAT THE BLAINE COUNTY BOARD OF COMMISSIONERS HEREBY AMENDS THE COMPREHENSIVE PLAN BY ADOPTING CHAPTER 7 - ECONOMIC DEVELOPMENT AND THE ASSOCIATED APPENDIX, TO BE USED AS A GUIDE FOR THE ORDERLY DEVELOPMENT OF BLAINE COUNTY. THIS CHAPTER REPLACES SECTION 3: ECONOMIC DEVELOPMENT, WHICH WAS ORIGINALLY ADOPTED BY BLAINE COUNTY RESOLUTION NO. 94-29 ON NOVEMBER 4, 1994.
