STATE OF IDAHO, ET AL TO INTERMOUNTAIN GAS COMPANY

THIS INDENTURE, made this 28th day of October, 1955, by and between the STATE OF IDAHO, acting by and through the State Board of Land Commissioners, CHARLIE BROWNING and VELTA BROWNING, husband and wife, of Gannett, Idaho, as party of the first part, and INTERMOUNTAIN GAS COMPANY of Boise, Idaho, as party of the second part;

WITNESSETH; That for and in consideration of the sum of FIFTEEN & 80/100 dollars (\$15.80), lawful money of the United States of America, receipt whereof is hereby acknowledged, the party of the first part does hereby grant to the party of the second part an easement for the purpose of constructing, maintaining and using, a natural gas pipeline over and across the following described lands situated in Blaine County, State of Idaho, to-wit:

A strip of land 25.0 feet wide, being the west 25.0 feet of Lots 2, 3 and 4, Section 18, and Lot 1, Section 19, Township 1 North, Range 19 East, Boise Meridian.

Total area herein described contains 3.04 acres, more or less.

It is further understood and agreed that in the event the lands hereinabove described are not used for the purposes herein specified for any five year period, the State Board of Land Commissioners may declare such right of way forfeited and the use of the lands will revert back to the State of Idaho or to the record owner of the lands.

IN WITNESS WHEREOF, the State Board of Land Commissioners has caused these presents to be executed by its President, the Governor of the State of Idaho, and countersigned by the Secretary of State and the State Land Commissioner.
