**LEGAL NOTICE ADVERTISEMENT FOR BLAINE COUNTY BID REQUEST:**

In accordance with Idaho Code, Title 67-2805 (2) (a), this Fire Mitigation Bid Request (Bid Request) is for the purchase of hazard fuel reduction services and shall be made pursuant to a competitive sealed bid process with the purchase to be made from the qualified contractor submitting the lowest bid price while also complying with bidding procedures and meeting the Scope of Work and Prequalifications.

Sealed proposals will be received by the Blaine County Clerk’s Office located at 206 1st Avenue South, Suite 200 Hailey, ID 83333, until 4:00 pm, local time, on Monday, November 26, 2018 to provide hazard fuel reduction services for the Heatherlands & Starweather Fire Mitigation Project located in Blaine County. Email proposals will not be accepted. All envelopes containing bids are to be clearly marked: “Fire Mitigation Bid Request” on the face of the envelopes. Bids will be opened and publicly read during The Blaine County Board of Commissioners Meeting on November 27, 2018, and will be awarded on December 4, 2018.

A public works contractor’s license for the State of Idaho is required to bid on this project. A performance bond, bid security and liability insurance are required as described in the bid Prequalifications. A mandatory site visit will be held at the Starweather Bridge, on Tuesday, November 13, 2018 from 10:00am-1:00pm.
